POW/MIA: The DPMO announced 22 APR that the remains of a U.S. serviceman, missing in action from the Korean War, have been identified and will be returned to his family for burial with full military honors. Army Master Sgt. Robert A. Stein, 29, of Jamestown, N.Y., will be buried April 27, in Arlington Heights, Ill. In late 1950, Stein and elements of the 31st Regimental Combat Team (RCT) were engaged by vastly superior numbers of enemy forces east of the Chosin Reservoir near Sinhung-ri, South Hamgyong Province, North Korea. On Dec. 1, 1950, remnants of the 31st RCT, known historically as Task Force Faith, began a fighting withdrawal to a more defensible position near Hagaru-ri, south of the reservoir. Stein was reported missing Dec. 2, 1950. After the 1953 armistice, surviving prisoners of war who returned during "Operation Big Switch" said Stein had died in a POW camp during an aircraft rocket attack. Stein's remains were not part of the 1954 United Nations and Communist Forces remains exchange known as "Operation Glory." Between 1991 and 1994, North Korea gave the United States 208 boxes of human remains believed to contain the remains of 200-400 U.S. servicemen. North Korean documents, turned over with some of the boxes, indicated that some of the remains were recovered from the area where Stein was last seen. In the identification of the remains, scientists from the Joint POW/MIA Accounting Command (JPAC) and the Armed Forces DNA Identification Laboratory (AFDIL) used circumstantial evidence, compiled by DPMO and JPAC researchers, and forensic identification tools, such as dental comparison, to identify Stein. They also used mitochondrial DNA-which matched Stein's cousin.

This months Promenade will be on May 22<sup>nd</sup> in Cameron, MO at Post 33 with dinner at 18:00 HRS and the Promenade will begin at 19:00 HRS.
